

EU shares lithium battery



Overview

Demand¹ for battery raw materials is expected to increase dramatically over 2040 (Figure 1), following the exponential growth of electric vehicles (EV) and, to a minor degree, energy storage system (ESS) applications. The supply¹ of each processed raw material and components for batteries is currently controlled by an oligopoly industry, which is highly concentrated in China. Although China is expected to remain the dominant supplier, total battery consumption in the EU will almost reach 400 GWh in 2025 (and 4 times more in 2040), driven by use in e-mobility (about 60% of the total capacity in 2025, and 80% in 2040). Demand of primary materials for batteries can be decreased as well as the criticality of raw materials supply through the adoption of various Circular Economy (CE) strategies, e.g. e.
